# ITEM 3

#### METHOD OF CANCELLING ITEMS

 As this tariff is supplemented, numbered items with letter suffixes, cancel correspondingly numbered items in the original tariff or in a prior supplement. Letter suffixes will be used in alphabetical sequence starting with A. Example: Item 445-A cancels Item 445, and Item 365-B cancels Item 365-A in a prior supplement which in turn canceled Item 365. Item 100-AA cancels Item 100-Z. Item 100-BB cancels Item 100-AA.

### ITEM 5

#### THE EXPORT DECLARATION MUST BE TREATED AS CONFIDENTIAL

1. The contents of all copies of the export declaration must be treated as confidential and may not be discolsed to others than the exporter or his agent by employees of Customs Service, the Department of Commerce, or other United States Government agencies, without written consent of the Secretary of Commerce.

#### **ITEM 10**

## ISSUANCE, USE AND REPRODUCTION OF AUTHENTICATED COPIES OF SHIPPERS EXPORT DECLARATION

- 1. A copy of a Shipper's Export Declaration authenticated by a Collector of Customs by certification, validation by numbering stamp, or any other method, may be supplied to exporters or their agents only where such a copy:
  - A. Is needed to enable the exporter to comply with the export control requirements of the Office of International Trade.
  - B. Is required, with the approval of the Secretary of Commerce, to be supplied by the exporter or his agent to an agency of the Federal Government, or
  - C. Is needed for presentation to the exporting transportation company as authentication for export. An authenticated copy of a Shipper's Export Declaration supplied to an exporter or his agent under any of these conditions may not be used for any other purpose nor may it be photostated or reproduced in any other form by the exporter or his agent, the Federal Government agency or by a transportation company or its agents.

### **ITEM 15**

#### **CLEARANCE ON INCOMPLETE CARGO MANIFEST UNDER BOND**

1.For clearance to be granted on incomplete cargo manifest(s), and before all Shipper's Export Declarations have been filed, the Collector of Customs may require Pro Forma Declarations (based on condition of goods under bond (see Note 1) to be filed enumerating shipments for which Declarations are missing.

# **EXPLANATION OF NOTE**

1. The condition of the bond for bonded goods is that a complete outward manifest of all cargo laden on board the vessel, together with all the Export Declarations covering all cargo, shall be filed with the Collector of Customs not later than the fourth (4th) business day (T.D. 51504) after clearance of the vessel.

# TARIFF 6571-J RULES

# **ITEM 20**

#### SHIPPER'S EXPORT DECLARATIONS

- 1. Before shipments destined to foreign countries or to Canal Zone of Panama, Guam, Puerto Rico, Samoa; Tutuila, and the Virgin Islands may leave this country, either by rail or water, the United States Government requires that specific information with respect to each shipment (carload or less-carload, as the case may be) be shown on a "Shipper's Export Declaration", and that such Declaration be filed with the United States Customs Collector at the port or border point of exit in his country. However, if Declarations for rail shipments to Canada are not delivered to the Collector of Customs prior to departure of such shipments from the United States, immediate exportation may be permitted upon the filing of Pro Forma Declaration therefor and the execution of a bond to produce the missing Declarations not later than fifteen (15) calendar days after the date of exportation. See Item 60, Paragraph 2.
- 2. Export statistics of the Department of Commerce are compiled from these Declarations and all data required therein must be furnished in the manner prescribed. The information given therein will be held as confidential.
- Shipper's Export Declaration (Commerce Forms 7525-V or 7525-V-Alternate-Intermodal) is not required on shipments from and to foreign countries transported through the United States in bond. (See Item 30).

#### SHIPMENTS TO UNITED STATES GOVERNMENT AGENCIES OR ESTABLISHMENTS

- 4. Collectors of Customs will require, in accordance with the provisions of the Regulations for the Collection of Statistics of Foreign Commerce and Navigation of the United States as amended by Foreign Commerce Statistical Decision 57, the filing of Shipper's Export Declarations for all shipments made to United States Government agencies or establishments in foreign countries or in the Territories and Possessions of the United States, except Alaska and Hawaii, whether such shipments are made by or for account of the United States Government agency or establishment, or by a private individual or concern, except in the FOLLOWING CASES in which the Shipper's Export Declaration NEED NOT BE FILED.
  - A. Shipments of office furniture, equipment and supplies to United States offices for the exclusive use of such offices;
  - B. Shipments of household goods and personal property to employees of the United States offices or to United States offices for such employees for the exclusive use of such employees;
  - C. Shipments of books, maps, charts and pamphlets made by United States Government offices to foreign libraries or Government establishments:
  - D. Shipments of military and navel supplies and equipment for the use of United States military and naval forces abroad.

# **ITEM 25**

#### PREPARATION OF SHIPPER'S EXPORT DECLARATION

- 1. The Shipper's Export Declaration MUST BE MADE IN TRIPLICATE (see Note 1) by the shipper, owner or authorized agent.
- 2. If the Shipper's Export Declaration is prepared by an agent of the shipper or owner, the authority to sign such Declaration must be in the form of a properly executed power of attorney, or in a less formal written authorization, such as that printed on the Declaration. The production of a power of attorney or authorization may be waived if the Collector of Customs has personal knowledge that the person signing such Declaration is authorized to do so, or is held out to the public by such shipper or owner as their agent. In every event the data required in the Declaration must be correct and must be based on personal knowledge of the facts stated therein, or on invoices or information furnished by the shipper or owner.
- 3. Separate Export Declarations are required for licensed and unlicensed commodities; i.e., licensed and unlicensed commodities should not be reported on the same Declaration.
- 4. On shipments covered by two or more licenses, quantities and values applicable to each license must be separately specified.
- 5. Export license number should appear on the line immediately following the item to which it relates, with an indication, as to whether the export is a PARTIAL or COMPLETE shipment against the license.
- 6. In the preparation of the documents, shippers will be required to conform to the line spacing on all copies.

### **EXPLANATION OF NOTE**

1. On shipments destined to Canada, the third copy of the Shipper's Export Declaration must be filed with the United States Customs Officer as reuired by Canadian Customs. On shipments destined to Mexico, the third copy is for use of broker at border.

### **ITEM 30**

# FORMS TO BE USED

- 1. The forms for Shipper's Export Declarations are Commerce Forms 7525-V or 7525-V-Alternate-Intermodal. These forms are reproduced as SAMPLE ONLY on pages 15 through 18 of this tariff.
- On shipments from or to foreign countries, transported through the United States in bond, Customs Form 7512 (Transportation Entry and Manifest of Goods Subject to Customs Inspection and Permit) and Commerce Form 7513 (Shipper's Export Declaration for In-Transit Goods) must be used. These forms are reproduced as SAMPLE ONLY on pages 12, 13 and 14 of this tariff.
- 3. On shipments withdrawn from bonded storage warehouses for export, Commerce Forms 7525-V or 7525-V-Alternate-Intermodal must be used. The shipment should be identified with an "F" (foreign products) in Column 12 on the Declaration Form.
- 4. On shipments withdrawn from bonded manufacturing warehouses for export, Commerce Forms 7525-V or 7525-V-Alternate-Intermodal must be used. The shipments should be identified with a "D" (domestic products) in Column 12 on the Declaration Form.
- 5. On shipments exported with benefit of draw-back, Commerce Forms 7525-V or 7525-V-Alternate-Intermodal must be used. The shipment should be identified with a "D" (domestic products) in Column 12 on the Declaration Form.
- 6. Rail carriers will not furnish Shipper's Export Declaration Form, which may be obtained from the Collector of Customs at a nominal charge. Shipper's Export Declaration may be printed by private parties, provided they conform to the official form in size, wording, color and arrangement, including the instructions on the back thereof. For the purpose of this requirement, the quality (weight) of paper stock used for the printing of the Shipper's Export Declarations by private parties must be NOT LESS THAN 16 POUNDS OR MORE THAN 20 POUND COMMERCIAL SUBSTANCE paper.

### ITEM 30 Cont'd

#### **FORMS TO BE USED**

- 7. Exporters should secure a copy of Commerce Department Schedule "B" (Statistical Classification of Domestic and Foreign Commodities Exported from the United States) as the information contained therein is necessary in the accurate preparation of these Declarations. Schedule "B" may be obtained from the Superintendent of Documents, Government Printing Office, Washington, DC 20402-9329, local Collectors of Customs or Department of Commerce Field Office, 500 Fifth Avenue, New York, NY 10110 for a nominal charge.
- 8. All Declaration Forms printed privately must show the Bureau of Budget approval numbers on the face of the form. These numbers must be shown in the UPPER RIGHT HAND CORNER of the appropriate form as follows:

Commerce Form No. Bureau of the Budget

7525-V Form Approved-Budget Bureau 41-R397.5 7525-V-Alternate-Intermodal Form Approved-O.M.B. No. 41-R2544 7513 Form Approved-Budget Bureau No. 41-R020-42

Thus, for Commerce Form 7513 the following notation should be printed:

"Form Approved-Budget Bureau No. 41-R020-42".

On forms not containing the Budget Bureau approval number, this information may be typed or stamped on the form in the LOWER LEFT HAND CORNER.

- 9. Shipper's Export Declarations, Commerce Forms 7525-V or 7525-V-Alternate-Intermodal, will NOT be required for shipments of sea stores, ship's stores, vessel supplies and vessel equipment of the departing vessel. This decision applies to vessels sailing under both the United States and Foreign flags.
- 10. Hay, straw, feed and other appurtenances necessary to the care and feeding of livestock while enroute on the ocean shall be considered part of sea stores of the carrying vessel and the Shipper's Export Declaration will not be required for the portion consumed during the voyage.
- 11. The Shipper's Export Declaration is, however, required for that portion which will remain after the voyage and will be delivered to the consignee. Estimated quantities, values and shipping weights may be shown on the Export Declarations covering the residual cargo.
- 12. Shipper's Export Declaration, Commerce Forms 7525-V or 7525-V-Alternate-Intermodal, are to be used in reporting shipments under the various United States Foreign Aid Programs, such as the Economic Cooperation Administration Program. For shipments made under the Economic Administration Program, the ECA authorization number is no longer required to be shown on the Shipper's Export Declaration.

### **ITEM 35**

#### INFORMATION TO BE SHOWN ON SHIPPER'S EXPORT DECLARATION

- 1. Shipper's Export Declaration must be legible and must be prepaid on typewriter, in ink, or with indelible pencil. The data required therein must be complete and must be inserted in the spaces provided therefor on the Declaration Form. Declarations carelessly or incompletely prepared or failure to provide a Declaration will result in shipments being detained at the port or point of exit, and such shipments will be subject to penalty charges for switching and storage, if any, and demurrage charges as published in agency or individual lines tariffs lawfully on file. Penalty charges for switching and storage, if any, and demurrage charges will not be assessed in instances where carriers have lost or mishandled documents.
- 2. Description of articles exported must be in sufficient detail to permit of exact classification hereof under Schedule "B". General designations, such as merchandise, fruits, groceries, dry-goods or machinery, should not be used. The total quantity and value of each individual article should be stated in one item.
  - The kind of packages, such as barrels, boxes or crates must be specified.
- 3. Quantities must be stated in standard commercial units designated in Commerce Department's Schedule "B", in net weight where required, exclusive of the weight of barrels, boxes or other bulk coverings, and of salt or pickle in the case of salted or pickled fish or meats. Fractions of quantities of less than one-half (1/2) will be dropped and one-half (1/2) or over will be increased to the next whole number.
- 4. The value of shipments to be stated in the Declaration is the value at the port or border points of exit, including all transportation and other charges from the port or border point of exit in the United States to destinations in foreign countries or non-contiguous territories must not be included in the value. Values must be stated in dollars only with fractions of less than fifty (50) cents being omitted and fractions of fifty (50) cents or over increased to the next dollar.
- 5. The value of all articles grown, produced or manufactured in whole or in part in the United States must be designated with a "D" (domestic products) in Column 12.
  - The value of articles of foreign origin exported from the United States in the same condition as when imported must be designated with an "F" (foreign products) in Column 12.
- 6. If foreign articles are subjected to any process of manufacture or alteration in the United States, they become domestic products and must be reported as such.
- 7. The country of final destination, that is the foreign country to which the goods are destined, must be shown. Care must be exercised to give the final destination of goods shipped through Canada to other foreign countries or of goods transshipped in the United Kingdom, etc., enroute to other foreign countries.
- 8. Processed, adulterated or renovated butter must be accompanied by a Certificate of Purity issued by the United States Inspector of Dairy Products. Certificates of Inspection must be presented to the Collector of Customs.
- Shipments of meats and meat food products to be exported must be accompanied by a Certificate of Inspection as required by regulations of the Department of Agriculture.
  - Shipments of livestock must be accompanied by a Certificate of Inspection from the Bureau of Animal Industry.
  - From time to time certain other commodities also must be accompanied by a Certificate of Inspection when required by Government regulations.

# TARIFF 6571-J **RULES**

### **ITEM 40**

#### DATES OF INPORTATION AND EXPORTATION

1. For statistical purposes the date of entry will be regarded as the date of importation; the date of clearance or the date of departure, if later, will be regarded as the date of exportation.

# **ITEM 45**

#### SHIPMENTS IN MORE THAN ONE CAR - DIVIDED SHIPMENTS

- 1. When shipments are forwarded at one time in such quantity as to require loading in or on more than one car, a separate Declaration should be furnished on each car in shipment in order to preclude any possibility of delay at the port or border of exit in event the cars become separated enroute, provided, however, on shipments to Canada or Mexico by rail consisting of two or more cars, a separate Shipper's Export Declaration shall be furnished for each car.
- 2. If a shipment is divided at the port of exit by accident or intention, part being exported in one vessel, airplane or car and part in another, the agent of the carrier will note the amount shipped on the Declaration attached to the vessel, airplane or car manifest. Declarations covering subsequent shipments must be prepared by the carrier's agent in duplicate from records of the previous shipment and be presented to the Collector when the remainder is shipped. The number of the original Declaration must be noted on the original and duplicate copy of the Declaration covering the remainder of the shipment.

### **ITEM 50**

#### TO WHOM SHIPPER'S EXPORT DECLARATIONS ARE TO BE DELIVERED PART 1

#### SHIPMENTS FROM INTERIOR UNITED STATES ORIGINS TO DESTINATIONS IN CANADA OR MEXICO

- 1. The Declaration must be delivered with the shipping instructions or Bill of Lading to the rail carrier at point of origin. If this is not practicable, it must be mailed to the exporting carrier (for exceptions and border crossing stations, see Note 1, below) at the point of exit so as to be available at such point to arrival of the shipment.
- 2. The shipper must make one of the following statements on the shipping instructions or Bill of Lading issued at the point of origin:
  - (1) "Shipper's Export Declaration is attached"
  - (2) "Shipper's Export Declaration has been mailed to
  - (3) "Shipper's Export Declaration will be delivered to at
  - and the specific statement made must appear on the waybill that accompanies the shipment or follows by mail. When the Export Declaration is delivered to the rail carrier at point of origin, in lieu of attaching it to the waybill, the Agent may, if considered necessary or desirable, dispatch it by U.S. Mail to the exporting carriers (for exceptions, see Note 1, below) at point of exit and appropriate notation concerning such handling must be placed on waybill.
- 3. When a shipment is diverted in transit to a point in Canada or Mexico, thereby requiring issuance of a Shipper's Export Declaration, the diversion instructions must contain a specific statement (see Paragraph 2, above) concerning the Export Declaration, and such statement must be added to the waybill accompanying the shipment.
- 4. Upon arrival of merchandise for exportation at the exit point or border port, the carrier must deliver to the Collector of Customs a car manifest giving marks and numbers, the same of the shipper or consignor, description of the goods and the destination thereof. This manifest may be the waybill, or a copy thereof, or a copy of the manifest prepared for the Foreign Customs. The required Shipper's Export Declaration, in duplicate, must accompany the car manifest or waybill when delivered to the Collector. The original will be retained in the files of the Collector at the border point of exit and the duplicate, when processed, will be mailed by the Collector's Office to the Export Statistics Section, Foreign Trade Division, Bureau of the Census, Washington, DC 20425.

# SHIPMENTS DESTINED TO SEABOARD FOR EXPORT TO A FOREIGN COUNTRY OR TO A NEW CONTIGUOUS TERRITORY OF THE UNITED STATES, EXCEPT ALASKA AND THE HAWAIIAN ISLANDS

- 5. On shipments from interior United States points, the Export Declaration, in triplicate, must be prepared and mailed by the shipper to the consignee, broker or ocean carrier at seaboard. Upon arrival of the goods, the seaboard Shipper's Export Declaration must be delivered by the consignee, broker or ocean carrier to the Collector of Customs.
  - If the shipment originates at, or the Shipper's Export Declaration is prepared at the port of exportation, the shipper must deliver the Declaration, in triplicate, to the Collector of Customs.
- 6. The Collector will retain the original and one copy, and indicate on the second duplicate copy, which is for the presentation by the shipper to the transportation company to be attached to the outward vessel or aircraft manifest, that it has been verified as a copy of the Declaration retained by the Collector. This second duplicate, or statistical copy, when returned to the Collector will be forwarded by the Collector to the Export Statistics Section, Foreign Trade Division, Bureau of the Census, Washington, DC 20425. The additional duplicate copy, or copies when required or authorized, shall be used by the exporter in conformity with export control regulations. All copies not used must be returned to the Collector.

# **ITEM 55**

# TO WHOM TRANSPORTATION AND EXPORTATION ENTRIES ARE TO BE DELIVERED

- 1. The Transportation and Exportation Entry, Customs Form 7512, should be delivered with shipping instructions or Bill of Lading to the rail carrier at point of origin. Shipping instructions, Bill of Lading and waybill should indicate that the shipment is moving "in bond". The Agent may, if considered necessary or desirable, dispatch it by U.S. Mail to the exporting carrier (see Notes 1 and 2) at point of exit and appropriate notation concerning such handling must be placed on the waybill.
- 2. The origin carrier must make one of the following statements on the waybill issued at the point of origin:
  - (1) "Transportation and Exportation Entry" is attached.

# **ITEM 60**

### PENALTY FOR FAILURE TO FILE SHIPPER'S EXPORT DECLARATIONS FOR EXPORTS BY RAIL

- 1. The agent of employee of any railway or transportation company, who shall transport any commodities into a foreign country by rail before delivering to the Collector of Customs the Shipper's Export Declaration covering the commodities transported as required by law, shall be liable to a penalty of \$50.00 for each offense.
- 2. Such liability shall not apply in those cases where Pro Forma Declarations have been filed and a bond executed to produce the missing Declarations not later than the 15th calendar day after the date of exportation.

# **ITEM 65**

#### SHIPPER'S EXPORT DECLARATIONS FILED WITH COLLECTOR OR CUSTOMS

1. Export Declarations must be in the hands of Customs Officials before vessels or cars will be allowed to depart from the United States.

### **ITEM 70**

# ENFORCEMENT OF RESTRICTIONS ON IMPORTS AND EXPORTS SUBJECT TO THE PROVISIONS OF THE PRESIDENT'S PROCLAMATION OF JULY 17, 1941, REGARDING "BLOCKED NATIONALS"

- 1. In respect of all merchandise intended for exportation after July 27, 1941, there shall be submitted with each Export Declaration a list of statement showing the name and address of each ultimate consignee of the merchandise unless such names and addresses are set forth in the appropriate Export Declaration. If the ultimate consignee, consignor, shipper or other person having an interest in the merchandise or in the transaction is named in the proclaimed list of certain blocked nationals, the exportation shall not be permitted except upon presentation of a license issued pursuant to Executive Order No. 8389, as amended, or instructions from the Treasury Department authorizing the transaction.
- 2. With respect to importations from any American republic of merchandise in which any person named in the proclaimed list appears to have an interest as consignor, seller, shipper or otherwise, the acceptance of entries for consumption and withdrawals from warehouse for consumption in respect of such merchandise tendered after July 27, 1941, shall be withheld pending presentation of a license issued pursuant to Executive Order No. 8389, as amended, or instructions from the Treasury Department authorizing the transaction.
- 3. Licenses cancelled by actual exportation, entry or withdrawal shall be endorsed to that effect and forwarded to the Federal Reserve Bank.
- 4. These regulations do not affect in any way the necessity for a license under the Export Control Act of July 2, 1940. Neither an export control license nor a license under Executive Order No. 8389, as amended, will be accepted in lieu of the other type of license.
- 5. Nothing in paragraphs 1 and 2 above shall be deemed to excuse any person from the necessity of obtaining a license in accordance with Executive Order No. 8389, as amended, and the proclamation of July 17, 1941, covering importations from or exportations to any person whose name appears on "The Proclaimed List of Certain Blocked Nationals".

(Customs Order T.D. 50433 of July 22, 1941)

### **ITEM 75**

#### SHIPPER'S EXPORT DECLARATION TO CONTAIN STATISTICAL EXPORT COMMODITY CLASSIFICATION CODE NUMBERS

- 1. Collectors of Customs will require the shipper or his agent to insert the appropriate statistical export commodity classification code numbers in the proper column of the Shipper's Export Declaration (Commerce Form 7525-V or the 7525-V-Alternate-Intermodal) before accepting the same
- 2. The commodity code numbers and the units of quantity to be inserted will be in accordance with the requirements of the following statistical schedule:
  - A. "Schedule B-Statistical Classification of Domestic and Foreign Commodities Exported from the United States" for exports of domestic and foreign products.
- The merchandise must be described in sufficient detail on the Shipper's Export Declaration to permit the verification of the commodity code inserted on the Export Declaration. (FCSD-18)

### **ITEM 80**

# REQUIREMENT FOR DESTINATION CONTROL STATEMENT OF SHIPPING DOCUMENTS COMPREHENSIVE EXPORT SCHEDULE §379.10(c)

#### (c)STATEMENT REGARDING ULTIMIATE DESTINATION ON DECLARATION, BILL OF LADING AND COMMERCIAL INVOICE

- 1. The provisions of this paragraph (c) apply to:
  - A shipment made under a general license where a Shipper's Export Declaration is required to be presented to the Collector of Customs, except for General License GIT.
  - 2. A shipment made under a validated license.

The provisions of this paragraph (c) apply to (1) a shipment made under a general license where a Shipper's Export Declaration is required to be presented to the Collector of Customs, except for General License GIT: (2) a shipment made under a validated license.

#### NOTE

The provisions of paragraph 379.10 (c) are inapplicable to shipments intended for consumption in Canada since these exportations to Canada require neither a validated nor a general license. However, these provisions are applicable to shipments through Canada to other foreign countries.

An appropriate destination control statement shall be entered on the Shipper's Export Declaration  $\odot$  in accordance with the provisions set forth below for all shipments subject to the provisions of this paragraph (c).

(i) The following statement shall be entered on the Declaration covering an exportation under either a validated or general license other than General License GIT, with the blank space filled in with the name of the country of ultimate destination set forth in the Declaration; unless, instead of this statement, an appropriate statement as provided in (ii) or (iii) below has been entered.

"These commodities licensed by the United States for ultimate destination (name of country). Diversion contrary to United States law Prohibited".

#### NOTE

In some instances the destination control statement used by an exporter, or his agent for a specific shipment may indicate that the shipment cannot be reexported to a destination to which the ultimate consignee or purchaser wishes to sell or distribute the commodities; however, the reexportation provisions of the Export Regulations (§§371.4 and 372.12) would permit the reexportation. Where this occurs and permission to distribute or resale is required by the foreign importer or any other party in possession of the commodities, the exporter, without obtaining written approval of the Bureau of Foreign Commerce, may inform the foreign importer or other party that distribution or resale may be made in

accordance with the reexportation provisions where applicable. In all other instances, written approval shall be obtained from the Bureau of Foreign Commerce.

(ii) Instead of the statement set forth in paragraph (i) above, the following statement m	nay be substituted with the blank spaces filled in as
instructed below.	
"These commodities licensed by the United States for ultimate destination	and for distribution or resale in
Diversion contrary to the United States law prohibited".	

If the exportation is made under a general license, other than General License GIT, insert the name of the country to which the shipment is being made in the first blank space, and the following words in the last blank space, "any destination except Soviet Bloc, Communist China, North Korea, Macao, Hong Kong or Communist controlled areas of Viet Nam and Laos unless otherwise authorized by the United States".

If the exportation is made under a validated license, insert in the first blank space the name of the country shown on the license as country of ultimate destination. In the last blank space, insert the names of the countries shown on the license as approved destinations for distribution or resale. If no country is shown on the license as approved for distribution or resale, insert the word "none" in the last blank space.

The Note following paragraph 379.10(c)(1)(i) above is also applicable to requests for permission to distribute or resale where the statement set forth in paragraph (ii) above is used.

(iii) Where a shipment is made under a general license, other than General License GIT, the following statement may be entered on the Declaration instead of the statements set forth in paragraph (i) and (ii) above.

"United States law prohibits disposition of these commodities to the Soviet Bloc, Communist China, North Korea, Macao, Hong Kong or Communist controlled areas of Viet Nam and Laos, unless otherwise authorized by the United States".

#### NOTE

The Note following paragraph 379.10(c)(1)(i) above is also applicable to requests for permission to distribute or resale where the statement set forth in paragraph (iii) above is used.

- (2) (i) No carrier by water, land or air shall issue and no licensee, shipper, consignor, exporter or consignee or their agents or any person, shall prepare or procure a Bill of Lading covering an exportation of a commodity with respect to which a Declaration has been authenticated by a Collector containing the applicable statement set forth in paragraph (c) (1) above, unless all copies of such Bill of Lading including all nonnegotiable and office copies except as provided in paragraph (ii) below, shall contain the same statement.
- (ii) In the case of shipments by air (other than airmail or air parcel post) the provisions of paragraph (i) above are applicable to: (a) any Air Waybill issued by a Consolidator (indirect carrier) for an exportation included in a consolidated shipment; or (b) any Air Waybill issued by a carrier or other person covering an exportation not included in a consolidated shipment. The provisions of paragraph (c)(1) above do not apply to a "Master" Air Waybill issued by a carrier to cover a consolidated shipment.
- (3) No licensee, shipper, consignor, exporter or agent thereof or any other person, shall prepare or issue any commercial invoice with respect to any shipment of commodities subject to the provisions of this paragraph (c), unless such invoice or invoices and all copies thereof, shall contain on the face thereof the applicable statement set forth in paragraph (c) (1) above.

No carrier shall release custody of a shipment of commodities covered by the provisions of this paragraph (c) to any party (including agents, on-carriers, foreign customs officials or any other person) without surrender by that party, to the carrier, of a copy of the Bill of Lading bearing on its face the applicable destination control statement set forth in paragraph (c) (1) above unless, simultaneously with release of the commodities, the carrier delivers to such party a written copy of the destination control statement covering the shipment as contained on the copy of the Bill of Lading in the carrier's possession. The written statement shall identify the shipment by Bill of Lading number, name of carrier, voyage number, date and port of arrival. The carrier shall secure and retain either a signed receipted copy of such written statement or other equivalent written evidence of such statement.

### **EXPLANATION OF REFERENCE MARK**

① Where the country of ultimate destination is Cambodia, Laos or Viet Nam, the destination control statement shall be filled in as required by §373.68 regardless of the country designation shown on the Shipper's Export Declaration.

# **ITEM 85**

# USE OF THE IN-TRANSIT SHIPPER'S EXPORT DECLARATION (COMMERCE FORM 7513)

- 1. In addition to the information now required to be shown on the form, the following additional information will be required by the Office of International Trade.
  - A. The name and address of the intermediate consignee in a foreign destination, if any, must be shown below the description of the commodities across columns 1-6.
  - B. Underneath the name and address of the intermediate consignee, also within columns 1-6, one of the following statements must be made, whichever is appropriate:
    - (i) FOR IN-TRANSIT SHIPMENTS OF FOREIGN MERCHANDISE:
      - "The merchandise described herein is of foreign origin".

NOTE - For purposes of export control regulations, foreign merchandise is defined in Section 371.9 paragraph (a) of Comprehensive Export Schedule No. 27 to include not only merchandise which is the growth, production or manufacture of a country other than the United States, but also commodities which were originally grown, produced or manufactured in the United States but which have been so altered by further processing, manufacture or assembly in the foreign country that such commodities have either thereby been substantially enhanced in value or have lost their original identity with respect to form.

(ii) FOR IN-TRANSIT SHIPMENTS OF DOMESTIC (Ú.S.) MERCHANDISE:

"The merchandise described herein is of the growth, production or manufacture of the United States".

In-transit merchandise is subject to the export control regulations of the Office of International Trade.
