The daily rate will be billed directly by Kasgro Rail Car Management to user. EXCEPTION D –. KRL will be responsible to bill and collect use and/or origin detention charges directly from Nooter/Eriksen, St. Louis, MO.

EXCEPTION E -. KRL will be responsible to bill and collect use and/or origin detention charges directly from Heavy Transport, Inc.
