Learning about Rail Document Interchange

Rail Document Interchange (RDI) is the central repository for all documentation required to safely travel on foreign tracks. The purpose of RDI is to centralize the storage of safety documentation for the Rail Industry while providing timely and accurate exchange of safety rule documents between interline partners to increase the safety of train crew members.

Overview

RDI enables railroad safety documentation teams to distribute and receive safety documents required by foreign line crews. Foreign carrier personnel automatically and immediately receive updated operational safety documents from the host road. Document updates are pushed from the publishing road to the central document exchange and repository, and are then immediately routed to the impacted foreign carriers. The safety document can then be consumed by the foreign railroad's current documentation system; giving affected crews immediate access to the proper safety documents on their internal systems.

RDI provides the following benefits:

- Provides timely and accurate exchange of safety operating rules documents between interline partners, which increases the safety of the Engineer/Conductor.
- Reduces administrative efforts to distribute safety rules to foreign carriers.
- Reduces the amount of time trains are delayed from moving due to delays in acquiring current safety documentation.
- Builds a framework for extension and utilization in other areas of the industry.
- Reduces lack of delivery to recipients with a more accurate subscription management capability.
- Provides access to safety operating rules documents to the entire industry via web portal.
- Enables railroads to easily view and compare processes with other railroads.
- Formalizes the secure access to safety operating rules documents.

After securely logging into RDI, you can search, view, and download any documents published in the repository. You can also upload and delete documents for your carrier as well as manage subscriptions for your carrier.

Getting Started

Access the Rail Document Interchange application by using Railinc’s Single Sign-On (SSO), a web application that provides convenient access to a variety of Railinc products. If you have an SSO login, go to the Railinc portal at <https://public.railinc.com/> and select the **Customer Login** link in the top right corner. Enter your user ID and password in the fields and select **Sign In**.

Registering to Use Railinc SSO

Each RDI user must register to use Railinc Single Sign-On. If you are not already registered, refer to the [Railinc Single Sign-On User Guide](#) for more information. Once you have completed SSO registration, request access to RDI within SSO.

Requesting Access to RDI

After you receive authorization to use Railinc SSO, you must request general access to RDI by following instructions in the [Railinc Single Sign-On User Guide](#).

Your level of access and authorization for RDI is determined when you request access through Railinc Single Sign-On. [Exhibit 1](#) shows a complete list of RDI roles as seen in SSO.

Exhibit 1. User Roles and Tasks

Task	Description
RDI Safety Operations User	This role enables Rail Document Interchange (RDI) users to create and manage subscriptions, search for documents, and manage folders and files. Users must request access under the mark for which they want to receive access.

Your assigned user role determines what functions you can perform. User roles are assigned by Railinc through the Single Sign-On interface ([Exhibit 2](#)).

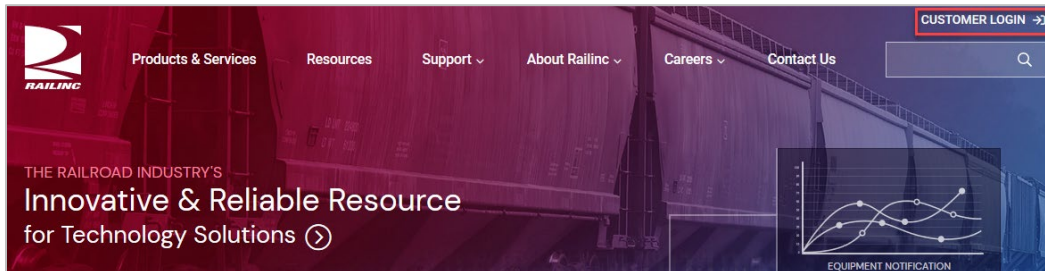
Once you receive email notification of access to RDI, you can log on and begin using RDI.

Use the following procedure to log into Rail Document Interchange:

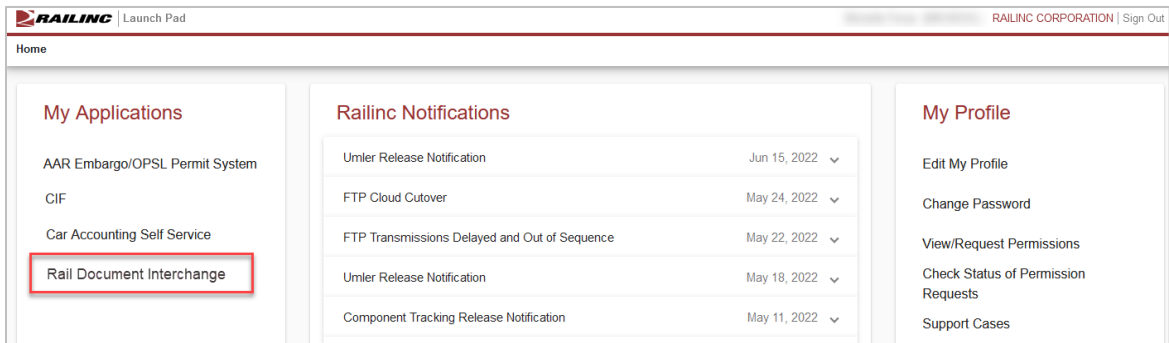
1. Open your internet browser and enter <https://public.railinc.com> to open the Railinc website.
2. Select the **Customer Login** link in the upper right of the page. The Account Access page is displayed.

3. In the Customer Login panel, enter your User ID and Password. Select **Login**. The Railinc Launch Pad is displayed.



Continue by selecting one of the following RDI menu options:

- Home** View lists of recent updates to subscribed documents as well as newly uploaded unsubscribed documents.
- Subscriptions** Create new subscriptions and manage active subscriptions.
- Search** Search for documents.
- Manage** Browse folders and manage files in folders owned by your carrier.

Logging Out

Select the **Sign Out** link to end an RDI session.

Viewing Recently Updated and New Documents

On the Home page, RDI has two tabs: Recent Updates and New Documents.

The Recent Updates tab, which is displayed by default, shows a list of documents to which you are currently subscribed that have been updated within the past week. You can view these documents by selecting the View File icon in the Action column. [Exhibit 5](#) shows an example of the **Recent Updates** tab.

Select the **New Documents** tab to see a list of documents added within the past month to which you are not subscribed ([Exhibit 6](#)).

You can view a document by selecting the View File icon in the Action column. You can subscribe to a document by selecting the Subscribe icon () in the Action column.

Note: The Location column shows the physical locations to which the document is applicable.

Creating New Subscriptions


You can create subscriptions to safety documents that have been uploaded by other carriers. You can subscribe to all documents or specific types of documents as well as documents that are only applicable to specific locations.

Note: You can only have one subscription per carrier.

Use the following procedure to create a new subscription:

1. Select **Subscriptions > Create New Subscription** from the RDI menu bar. The Create New Subscription page is displayed ([Exhibit 7](#)).

2. Select the carrier to whose document(s) you want to subscribe. The Create New Subscription page expands with fields that enable you to specify the documents to which you want to subscribe ([Exhibit 8](#)).

3. Select checkbox(es) in the Country field to indicate the countries to whose safety documents you want to subscribe.
4. Select checkbox(es) in the System Documents field to indicate the types of safety documents to which you want to subscribe.
5. If you want to subscribe to documents that are applicable to specific locations, select checkbox(es) in the Location-Specific Documents field to indicate your subscription preferences. Depending on your selections, additional location-specific fields are displayed, which enable you to further refine your subscription preferences.
6. Type a descriptive name for the new subscription in the Subscription Name field.
7. Select **Submit**. Your subscription is saved and activated. The Manage Active Subscriptions page is displayed (see [Managing Your Subscriptions](#) on page 9).





Managing Your Subscriptions

Select **Subscriptions > Manage Active Subscription** from the RDI menu bar to manage your subscriptions to other carriers' documents. The Manage Active Subscriptions page is displayed ([Exhibit 7](#)).

The Manage Active Subscriptions page displays all the active subscriptions for your carrier. This page displays one row for each subscription, and allows you to select actions to perform for each subscription. Select an icon in the Action column to perform the following tasks for the subscription contained in the selected row:

-  Expand the row to show additional documents and/or locations included in the subscription.
-  Edit (modify) the existing subscription. The Edit Subscription page is displayed. This page is essentially the same as the Create New Subscription page except that the carrier cannot be modified ([Creating New Subscriptions](#) on page 7).
-  Delete an existing subscription from your carrier to another carrier's documents. A confirmation pop-up is displayed.
-  Sync the documents included in the subscription. Syncing pushes the most recent version of all the documents included in the subscription to you (either via an established web service or email). A confirmation pop-up is displayed.

Searching for Documents in RDI

Select **Search** from the RDI menu bar to search for and view any documents contained in the RDI repository for any foreign carrier. The Search Documents page is displayed ([Exhibit 10](#)).


Document Name / ID Enter a specific document name (or part of a document name) or a document ID to include in the search. Searching using this method returns any documents whose name contains the text you specify.

Upload Date From Use the calendar icon to select the earliest upload date to include in the search.







Upload Date To Use the calendar icon to select the most recent upload date to include in the search.


Once you have entered your search parameters, select **Search**. Your search results are displayed ([Exhibit 11](#)).

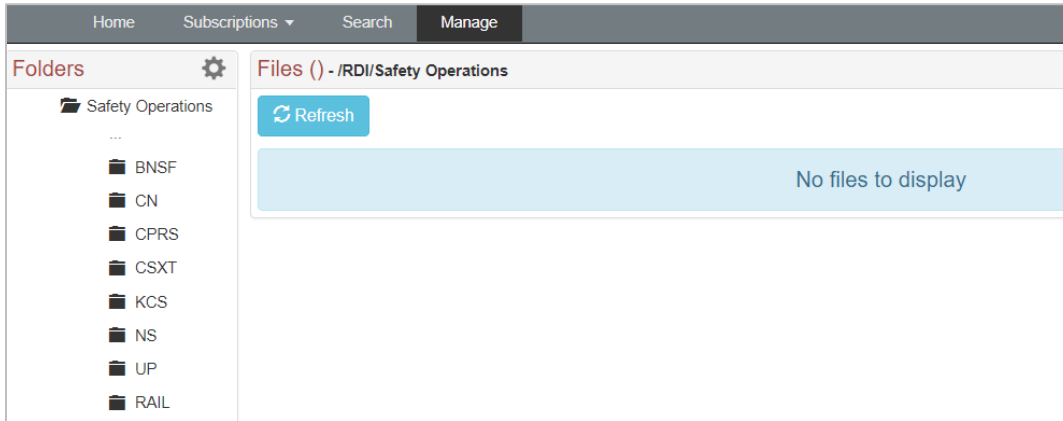
The Search Results section shows the documents that met the criteria you specified. You can select  to view and modify your search criteria. Select an icon in the Action column to perform the following tasks for a document listed in the selected row:

-  View the document listed in the Search Results.
-  Subscribe to an unsubscribed document listed in the Search Results.

Managing Documents in RDI

Select **Manage** from the RDI menu bar to view folders and files in RDI. The Manage Folders and Files page is displayed ([Exhibit 12](#)).

Exhibit 12. Manage Folders and Files Page



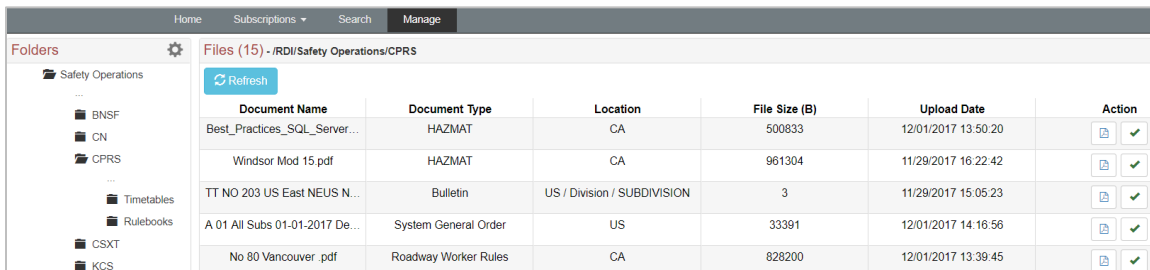

Browsing Other Carriers' Folders and Files

The Manage Folders and Files page enables you to browse any and all folders in RDI – there are no restrictions. Select a carrier's folder to see folders and files owned by that carrier ([Exhibit 13](#)).

Exhibit 13. Manage Folders and Files Page (Folders and Files Owned by another Carrier)

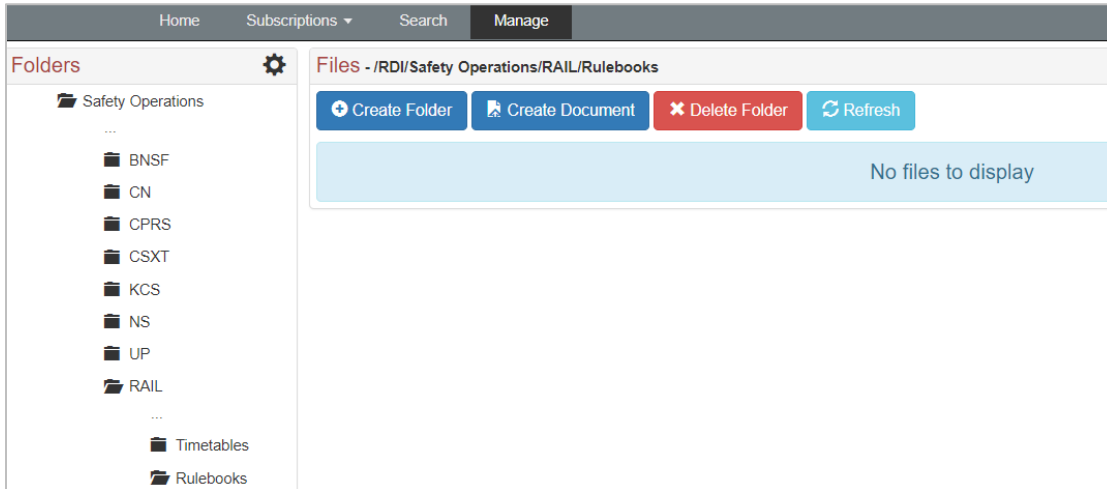


If you do not represent the carrier that owns the folder, the only tasks you can perform are to select **Refresh** to update the display of folder contents, or select the View File () or Subscribe () icons in the Action column.

Managing Your Carrier's Folders and Files

If you represent the carrier that owns the folder you are viewing (shown below in [Exhibit 14](#)), you can perform several management tasks.

When working with a folder owned by your carrier, you can select the following task buttons:


- Create Folder** Create a folder as a subfolder to the currently selected folder.
- Create Document** Create (upload) a document of any filetype in the currently selected folder.
- Delete Folder** Delete the currently selected folder. The folder must be empty before you can delete it.
- Refresh** Update the display of folder contents.

You can also select the Download Subscribers icon (⚙️) to download a CSV file containing a list of all foreign roads who have subscribed to any of your documents.

Creating (Uploading) a Document

You can create (upload) a new document in any folder owned by your carrier. From the Manage Folders and Files page, select a folder owned by your carrier, and then select **Create Document**. The Upload Document pop-up is displayed ([Exhibit 15](#)).

Complete the fields in the Upload Document pop-up:

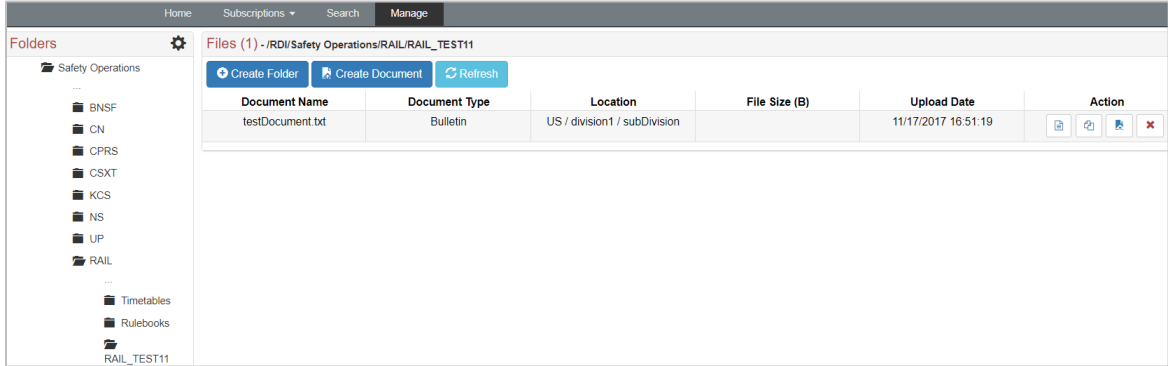
1. Select **Choose File** and locate the file you want to upload to RDI.
2. Use the **Document Type** drop-down list to select the document type. If you select a system-wide document type, you are not required to add division or subdivision information. If you select a location-specific document type, you are required to add a division (subdivision information is optional).
3. Use the **Country** drop-down list to select the country to which the document is applicable.
4. The **Document Name** is prepopulated with the file name, but you can modify as needed. Limit the document name to 50 characters, and only use alphanumeric characters, spaces, dashes, underscores, and periods.
5. Enter a **Division** (if a location-specific document type). Limit the division name to 50 characters, and only use alphanumeric characters, spaces, dashes, underscores, and periods.
6. Enter a **Subdivision** (optional for location-specific document types). Limit the subdivision name to 50 characters, and only use alphanumeric characters, spaces, dashes, underscores, and periods.
7. Optionally, enter the **Version** number. Note that the version number must be maintained manually by the uploader.

Select **Submit** to upload the new document and its properties to the RDI repository. The document is uploaded immediately.

Updating Documents Owned by Your Carrier

You can modify documents in any folder owned by your carrier ([Exhibit 16](#)).

When you are working with files in a folder owned by your carrier, you can select the following icons in the Action column in the row associated with a file to perform tasks for that file:



-  View the document/file.
-  Update the properties of the document. When you select the **Update Properties** icon, the Update Document pop-up is displayed ([Exhibit 17](#)). Make any needed updates to the properties and select **Submit**.

-  Replace the content of the document. When you select the **Replace Content** icon, the Update Document pop-up is displayed ([Exhibit 18](#)). Select **Choose File** and locate an updated version of the document. Select **Submit** to replace the existing file with the updated file.
